• **Electronic Billing** – The handout I gave you today shows the last 3 months of deposits with also deposits and invoicing totals for this FY. To date we have invoiced a continuing FY total of \$479,088.03 and we have received in a total today FY to date \$460,727.71.

So that is 97% of amount invoiced has been collected for our FY so far.
